**JUDGMENT**

**THIS MOTION**, made by the Plaintiff, Grisel Alonso, as Receiver for Elm Tree Investment Advisors, LLC, Elm Tree Investment Fund, LP, Elm Tree 'e' Conomy Fund, LP, Elm Tree Motion Opportunity, LP, and Etopia, LP, for an order granting summary judgment against the Defendant, Alina Talsky, was read this day at the Court House, 393 University Avenue, Toronto, Ontario, M5G 1E6.

**ON READING** the materials filed by the Plaintiff, and on hearing the submissions of counsel for the Plaintiff, no one appearing on behalf of the Defendant,

1. **THIS COURT ORDERS AND ADJUDGES** that this motion for summary judgment is granted and declares that the Defendant shall pay the Plaintiff \$22,731.05 (USD), pursuant to s. 121 of the *Courts of Justice Act*, in an amount of Canadian currency sufficient to purchase \$22,731.05 (USD) at a bank in Ontario listed in Schedule 1 to the

*Bank Act* (Canada) ("bank"), and based upon the exchange rate applicable for Canadian dollar purchases of U.S. currency quoted by the bank at the close of business on the day before payment of the obligation is made to the Plaintiff.

2. **THIS COURT ORDERS AND ADJUDGES** that the Defendant shall pay prejudgment interest to the Plaintiff in the sum of \$293.45 (USD), pursuant to s. 121 of the *Courts of Justice Act*, in an amount of Canadian currency sufficient to purchase \$293.45 (USD) at a bank in Ontario listed in Schedule 1 to the *Bank Act* (Canada) ("bank"), and based upon the exchange rate applicable for Canadian dollar purchases of U.S. currency quoted by the bank at the close of business on the day before payment of the obligation is made to the Plaintiff.

3. **THIS COURT ORDERS AND ADJUDGES** that the Defendant shall pay to the Plaintiff the sum of \$ 500 (CAD) for costs of this motion and action.

This judgment bears interest at the rate of 3.0% per year from its date.
