**ORDER REGARDING RECEIVER'S FILING OF  
AMENDED REVISED DISTRIBUTION CHART**


THIS CAUSE is before the Court upon the Court's review of the Receiver's May 28, 2019 Notice of Filing Revised Distribution Chart [DE 219] and the Receiver's June 6, 2019 Notice of Filing Amended Revised Distribution Chart [DE 220]. The Court has carefully considered the filings and is otherwise fully advised in the premises.

The Receiver has abandoned its rising tide calculations and proposed distribution amounts set forth in the Revised Distribution Chart [DE 219-1] and is proceeding on its rising tide calculations and proposed distribution amounts set forth in its Amended Revised Distribution Chart [DE 220-1], which was filed after the May 28, 2019 deadline. *See* [DE 218]. Therefore, the Court will allow additional time for claimants to file any objections to the Amended Revised Distribution Chart [DE 220-1].

Based upon the foregoing, it is hereby **ORDERED AND ADJUDGED** as follows:

1. Claimants will have until **July 15, 2019** to object in writing to the Receiver's Amended Revised Distribution Chart [DE 220-1]. Claimants shall: (i) file their objections with the Court; and (ii) send their objections to the Receiver via email at ElmTreeInfo@Moecker.com, or by mail to the Receiver's office, care of Grisel Alonso, Receiver, Michael Moecker and Associates, 1883 Marina Mile Blvd., Suite 106, Ft. Lauderdale, FL 33315, **to be received** no later than **July 15, 2019**;
2. If objections are sent to the Receiver by regular mail, Claimants must request proof of delivery and/or return receipt;
3. If a Claimant does not object within the time frame provided, the Receiver's Amended Revised Distribution Chart [DE 220-1] will be deemed sustained with prejudice as to that Claimant, and the right of that Claimant to object will be deemed irrevocably waived;
4. On or before **July 25, 2019**, the Receiver shall file her responses to timely-filed objections;
5. In the event that Objections to the Amended Revised Distribution Chart [DE 220-1] are timely filed, the Court will hold a hearing on the Objections and the responses thereto at **10:30 A.M. on Friday, August 2, 2019**, in Courtroom 205B at the U.S. Courthouse, 299 E. Broward Boulevard, Fort Lauderdale, Florida;
6. The Receiver shall serve a copy of this Order on each Claimant by electronic mail when possible, using the most recent contact information available to her, and shall post a copy of this order on the Receivership website:
